

Heikes on Health Care

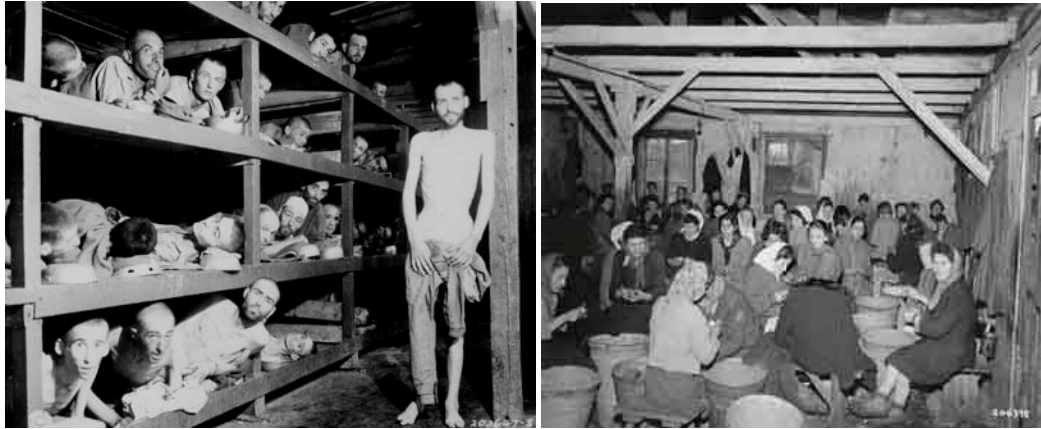
The Prelude

History Lesson Anyone? Author Robert Lifton in his book, “The Nazi Doctors” reveals what happens when an ideology and demagoguery to promote it, gains hold of a nation’s medical community.

Introduction Lifton writes, “At its heart is the transformation of the physician, of the medical enterprise (itself from healer to killer). That transformation requires us to examine the interaction of Nazi political ideology in the effects of the individual and collective behavior”. That in turns takes us to significance of medical-ized killing“. “Prior to Auschwitz and other death camps, the Nazis established a policy of direct medical killing; that is, killing within medical channels, by means of medical decisions carried out by doctors and their assistants. The Nazis called this program “euthanasia.” Since, for them, this term, camouflaged mass murder.”

“Life Unworthy of Life” / “Euthanasia Direct Medical Killing”

There was considerable advocacy elsewhere of “mercy killing” including its recommendation in the United States by the same Foster Kennedy (an American) who was honored at the Heidelberg jubilee. Anyone trained in American medicine has personal experience of doctors, nurses, and medical attendants colluding in the death of patients, usually children, who have been extremely impaired physically and mentally. But those practices have been restrained by legal limits and strong public reaction, and have not developed into a systematic of killing those designated unworthy of living. (The Heidelberg Jubilee was held in 1936, in Germany with some the world’s elite doctors, psychiatrists and psychologists; eight of whom were from the United States. The topics of discussion included sterilization, eugenics and euthanasia, killing to promote healing - GLH)

Theme and Melody

Lifton makes reference to, “The Crucial work---The Permission to Destroy Life Unworthy of Life”, published in 1920 with two German professors: the jurist, Karl Binding - who retired after 40

years at the University of Leipzig, and Alfred Hoche, professor of psychiatry at the University of Freiburg.

Carefully argued in numbered-paragraph form the traditional philosophical treatise includes as “unworthy life”, not only the incurably ill, but large segments of the mentally ill, the feeble-minded, as the entire concept. They stressed the therapeutic goal of that concept; destroying life unworthy of life is purely a healing treatment and a “healing work”. Binding’s section explored the doctor’s legal responsibility in “death assistance” and the “killing of the consenting participant,” and in the killing of “incurable idiots” unable to consent. He advocated a carefully controlled juridical process, with applications for killing evaluations by a three-person panel including a general physician, a psychiatrist, and a lawyer.

A patient who gave consent to be killed would have the right to withdraw that consent at any time, but there was also an emphasis on the legal protection of physicians involved in the killing process. Hoche, in his section, insisted that such a policy of killing was compassionate and consistent with medical ethics; he pointed to situations in which doctors were obliged to destroy life (such as killing a live baby at the moment of birth, or interrupting a pregnancy to save the mother). He went on to evoke a concept of “mental death” in various forms of psychiatric disturbance, brain damage, and retardation. He characterized these people as “human ballast” and “empty shells of human beings” terms that reverberate in Nazi Germany.

“Putting such people to death”, Hoche wrote, “is not to be equated with other types of killing, but (is) an allowable useful act.” He was saying these people are already dead. Hoche referred to the tremendous economic burden such people cause to a healthy society to bear; especially those who are young, mentally deficient, and otherwise healthy who would require a lifetime of institutionalization. He specifically medicalized the organic concept of the state by his insistence that “single less-valuable members have to be abandoned and pushed out.” He added a striking note of medical hubris in insisting that “the physician has no doubt about the hundred percent selection” and “proven scientific criteria” to establish the “impossibility of improvement of a mentally dead” person. But he ultimately, revealed himself to be a biological visionary “A new age will come which from the standpoint of a higher morality will no longer heed the demands of an inflated concept of humanity and an overestimation of the value of life as such.”

Indeed from the time of Jost, war had been invoked by advocates of direct medical killing. The argument went, that the best young men died in war, causing a loss to the Volk (folk; or to any society) of the best available genes. The genes of those who did not fight (the worst genes) then proliferated freely, accelerating biological and cultural degeneration. (Hence, the majority of the US Congress; GLH.)

These were some of the ideas grafted into the Nazi party and when Hitler took control. He went about the job of implementing these ideas to include racial purity. From 1933 to 1939 over 39 healing centers (concentration camps) were set up for “treatment”. Eventually they went on to help treat those who were insane, malformed, imbecilic,

communists, social democrats, Catholics, Jehovah witnesses, Jewish, Russians, Czechs, Poles, Hungarians, gypsies, homosexuals - anyone who held any belief that was outside the thought and ideology being expounded and being taught by the Nazi party. Laws were put in place to lend legitimacy to the “healing through death philosophy”. Doctors were willing accomplices in these strategies of life unworthy of life. Over 15 million people died in these healing centers, including Six million Jews and Nine million others. From 1939-1945: Experiments in human degradation and mutilation, which are beyond any normal understanding, were perpetrated. Slave labor of those who had been captured, where – “work for freedom” was the mantra and starvation was their feed.

In the eyes of the “doctors” and guards, who were under the mantel of a better racial and genetic breeding, those people who were outside the established borders of Nazi ideology were viewed and as being no better than rats or mice, more plentiful for experimentation. When one of these genetic inferiors reached one of the “healing centers“, the ramp “doctors” would select those who were worthy of life and who were worthy of death (those to be sent to the gas chambers, shot, or injected with various poisons or starved to death). Even those who were selected to live, after a series of either medical experimentation (human lab rat) work detail (slave labor) or prostitution, servicing the guards and doctors, often were “healed by medical-ized killing”. It was best for the Nation, future generations, and all in the name of humanity. For the ones being murdered it promised healing and a promotion of better breeding for the salvation of human race, of course.

My-my-my, how wonderful it is when an ideology gains control of the Health and Human Services of a Nation. Or should I say Health Insurance companies? And you thought it could never happen in the good old U.S of A.

Death panels anyone? The Selection of who lives and who dies - Planned Parenthood? Ye blind and desolate; you see the American test case of life unworthy of life has already happened. Abortion is described earlier in this paper is “selection”.

Does anyone remember the first selection of life unworthy of life, during the last Bush administration? The courts decided the fate of an American citizen, guilty of living? Not being charged with any crime against humanity!
